INTRODUCTION

The 2010 demolition derby season is fast approaching. At the time this booklet went to the printers, we have two (2) derbies scheduled for the 2010 season.

Each demolition derby listed within this booklet will be governed by its own specific rules and regulations. In addition to their own specific rules and regulations, all of these derbies will also be governed by the BLF Productions rules and regulations.

You may receive additional mailings about other derbies put on by **BLF PRODUCTIONS, LLC** when, and if the details are worked out on these other derbies. You will receive additional information pertaining to them, in the form of a flier, entry form, and a short letter about the purse and any rule change or addition, but this booklet will be mailed out only once a year due to the high cost of postage. In the center of this booklet, you will find an entry form for each demolition derby listed within these pages. All information contained within this book is also available on the Internet at our Web site www.kci.net/~blf and our E-mail address is blf@kci.net.

This set of rules has been developed over the past 32 years. They are designed to outline the basic minimum you have to do to a car and limit the maximum changes you can make to a car. Safety is our first concern and some of the rules added over the years, were added due to safety. Others were added because a driver or car builder took a loophole and, or a gray area and went to far. Individuality and imagination are all a part of building a car, but please keep your imagination within this set of rules. These rules are designed to make the competition even and non-discriminative.

There are four basic parts to demolition derby participation. The first is the type car used. Some cars are more suitable for demo derbies than others. The deciding factors to a car are usually availability, driver's preference and economics. Second there is the preparation. If one driver or builder chooses to do less to his car than the next guy, then it could come down to preparation. (BLF Productions LLC. demolition derbies are welded derbies, therefore if you bring a limited welded car or a car that is not welded to a BLF Productions demolition derby, please do not come complaining to the officials about the fact that you brought a knife to a gunfight.) Third, there is the driver. If two cars of the same type and model are built almost identically the same, and they both are within the rules, it will, quite possibly, come down to the driver. Last but not least is the luck factor; there is always a little luck involved in a successful demolition derby event. Therefore we at BLF PRODUCTIONS, LLC wish you all, the best of luck, in the up coming 2010 demolition derby season.

FOR THE RECORD

Although, the idea of using BLF PRODUCTIONS, LLC, RULES AND REGULATIONS, as a means of simplifying and trying to use a standard set of rules, (unless BLF Productions, LLC is actually staging the derby), the interpretation of some portions and aspects of the 2010 BLF PRODUCTIONS, LLC, RULES AND REGULATIONS may vary from one derby to the next. If you should inquire about a derby being staged somewhere, and you're told that they will be using BLF rules for that specific derby, then please ask who is staging and promoting that derby. If the answer is someone other than BLF Productions, LLC or the judges that BLF Productions, LLC uses, then they are not running BLF Productions, LLC, RULES & REGULATIONS!

To Drivers and Pit Crews,

This year's Greeley Stampede celebration kicks off Thursday, June 25th, and runs through Sunday, July 4th, 2010 at Island Grove Regional Park in Greeley, Colorado. This year's derby will be on **Sunday, June 27th, 2010**, starting at **2:00 P.M.** The total purse for this derby will be **\$20,000 (Guaranteed)**. Again, should special circumstances arise during the course of this derby, the purse may exceed the guaranteed amount, as it has on almost all the preceding derbies hosted by the Greeley Stampede.

There will be no limit placed on the number of cars being allowed to enter and participate at this derby, the more the merrier. The purse break down for this event is as follows.

The total guaranteed purse, as it has been for the past 24 years will be paid out. This year's purse of \$20,000.00 will be no exception. The scheduled heat payouts may be adjusted, subject to how many cars are participating in each event and any excess heat money may be diverted to another class or to one of the main events. The main event scheduled payouts will never be decreased, but may be increased.

New this year, we will run a truck heat. This heat will be staged prior to the full size class main event. The truck rules are included in this envelope with the BLF Productions, LLC schedule & derby information booklet.

This year, again, we will have only one compact heat. We have found from past events that the compact class attrition rate is 50 percent or higher when trying to run multiple heats therefore we will stay with a single event. This heat will be staged prior to the Truck class event.

REGISTRATION for this year's derby is \$75.00 all classes, which includes (1) pit pass for the driver. If a driver brings more than one class of car or truck, (i.e.) A full size car and a compact car, a full size car and a truck, a compact car and a truck or a vehicle in each class and the same driver is to drive both or all vehicles that driver

may use the same number on all vehicles driven by that specific driver. As previously stated in this letter there will be no limit placed on the number of cars entering this derby, therefore it is not necessary to send your entry fee in advance, but we do ask that you pre-register your car to expedite the paper work for this derby and once again, it will be, if you want a certain number for your car, be the first to register that number. If you do pre-register a car and send an entry fee in advance, then, cannot make it to the derby; **Your Entry Fee Will Be Refunded.** All that I ask, is that you please try to notify me in advance that you will not be able to participate. If you cannot contact me before the derby, then within a day or two after the derby, please contact me as to the fact that you were unable to attend the derby and I will see that your money is refunded. Please, first read the entry form and then fill it out completely, prior to mailing it. Telephone numbers are a must, so please provide a good number where you can be reached. I will contact you by phone only, if someone else has already registered your number or there are other problems with your registration form; therefore it is absolutely imperative that you provide good telephone numbers where you can be reached.

Additional Pit Passes may be purchased at the back gate only, for \$25.00 each. **Please do not mail money in advance, for additional Pit Passes.** All additional Pit Passes must be purchased at the back gate the day of the derby. All individuals receiving pit passes must sign a release of liability at the time of purchase.

The back gate will open at **7:00 A.M.** the day of the derby and closes at **12:00 P.M.** If your car hasn't arrived and checked in at the registration booth prior to 12:00 P.M. your car will not get past the back gate to the inspection area. All cars participating in the derby must have checked in at the registration booth prior to 12:00 P.M. This year's derby is starting 2 hour and 30 minutes earlier this year cutting down on the inspection window, I anticipate a mad house, as we will start the derby at **2:00P.M.** Sharp! Therefore, please arrive at the back gate as early as possible. **THERE WILL BE NO EXCEPTIONS!!!!**

ALL GLASS is to be removed before the car arrives at the derby. **THAT MEANS ALL GLASS.** If your car has broken glass in it, it will be removed before it is allowed through the back gate. If it has plastic in it, take it off; it serves no purpose, as this derby is being run in a rodeo arena. If it's going to break or fall off, **TAKE IT OFF!**

Also, **RULE G, NO ALCOHOL...** if it is determined by an officer of the law, and there is always at least one of them in the pit area, that any individual that is drinking before the derby starts, while the derby is in progress, or intoxicated, he or she will be escorted to the gate and sent on their way and also a chance of receiving a citation and an invitation to visit the county court.

For those of you who might be planning to arrive in Greeley a day or two early, Friday, **June 25th**, “**Craig Morgan**” and “**Joe Nichols**”, opening with “**David Nail**” will be performing in concert at **8:00 P.M.** in the Stampede Arena.

Saturday, **June 26**, “**Keith Urban**” will be performing in concert in the Stampede Arena at **9:00 P.M.**

The Greeley Stampede Demolition Derby is promoted as an unusual spectator attraction. In the interest of safety, drivers and mechanics are subject to and must obey the following rules and regulations.

- A. Any letter mailed with the rules or notification of one of our demolition derbies is considered an official supplement to the rules and regulations that might have already been mailed out. The 2010 BLF PRODUCTIONS, LLC rules and regulations will be used in this demolition derby.
- B. Each driver must fill out an entry form completely.
- C. Each driver must provide his or her social security number on the entry form, failure to do so will result in an invalid and incomplete entry form.

To Drivers and Pit Crews,

BLF Productions has been contracted to stage a demolition derby at the 2010 Boulder County Fair, which kicks off August 3rd and runs through August 7th. The Demolition Derby will be held on **Saturday, August 7th**, starting at **6:00 P.M.**, at the Boulder County Fair grounds in Longmont, Colorado. This will be our seventh year in Boulder, and hopefully, we can increase the amount of cars to insure future derbies and larger purses. The total purse for this derby is **\$13,000.00 (Guaranteed)**. Should special circumstances arise during the course of this derby, the purse may exceed the guaranteed amount.

There will be no limit placed on the number of cars being allowed to enter this derby. It will be open to any and all participants, the more the merrier. There will be a truck class (one heat only) run at this derby, along with compacts and the full size division. We are hoping for a 80-car turn out for this derby with at least 40 Full size division cars, 30 Compact division cars and 10 trucks. The purse for this derby breaks down as follows.

The scheduled heat payouts may be adjusted, subject to how many cars are participating in each event and any excess heat money may be diverted to another class or to one of the main events. The main event scheduled payouts will never be decreased, but may be increased.

REGISTRATION for this year's derby is \$50.00 per car, which includes (1) pit pass for the driver. As previously stated in this letter there will not be a limit placed on the number of cars entering this derby therefore it is not necessary to send your entry fee in advance, but we do ask that you pre-register your car to expedite the paper work for this derby and once again, it will be, if you want a certain number for your car, be the first to register that number. If you do pre-register a car and send an entry fee in advance, PLEASE make checks payable to:

BOULDER COUNTY FAIR DEMOLITION DERBY. If, then for some reason you cannot make it to the derby, **Your Entry Fee Will Be Refunded**. All that I ask, is that you please try to notify me

in advance that you will not be able to participate. If you cannot contact me before the derby, then within a day or two after the derby, please contact me as to the fact that you were unable to attend the derby and I will see that your money is refunded.

Please, first read the entry form and then fill it out completely in black ink, prior to mailing it. Telephone numbers are a must, so please provide a good number where you can be reached. I will contact you by phone only, if someone else has already registered your number or there are other problems with your registration form; therefore it is absolutely imperative that you provide good telephone numbers where you can be reached.

Additional Pit Passes may be purchased at the back gate only, for \$25.00 each. **Please, do not mail money in advance for additional Pit Passes.** All additional Pit Passes **must** be purchased at the back gate the day of the derby. All individuals receiving a pit pass must sign a release of liability at the time of purchase.

The back gate will open at **10:30 A.M.** the day of the derby and closes to car registrations at **4:30 P.M.** If you have not arrived and checked in at the registration booth prior to 2:00 P.M. your registration will not be accepted and your car will not get into the pit area. If your car is pre-registered, it must still be at the back gate and you must have checked in at the registration booth prior to 4:30 P.M. We will start the derby at **6:00 P.M.** sharp! Therefore, please arrive at the back gate as soon as possible.

I will stress: **ALL GLASS** is to be removed before the car arrives at the derby. **THAT MEANS ALL GLASS.** If your car has broken glass in it, it will be removed before it is allowed through the back gate. If it has plastic in it, take it off; it serves no purpose, as this derby is being run in a rodeo arena. If it's going to break or fall off, **TAKE IT OFF!**

Also, **RULE G, NO ALCOHOL...** if it is determined by an officer of the law, and there is always at least one of them in the pit area, that any individual that is drinking before the derby starts, while the derby is in progress, or intoxicated, he or she will be escorted to the gate and sent on their way and also a chance of receiving a citation and an invitation to visit the county court.
